WORKPLACE GIVING

Your regular donations through payroll giving to the Wakatipu Community Foundation will help the Wakatipu region forever. It will help us to respond to needs in our community both now and forever.

Workplace Giving is a simple, effective and voluntary scheme which allows employees to make donations directly from their pay to the Wakatipu Community Foundation. This is a simple way to support your local community.

Employees receive an immediate tax credit for their donations instead of having to retain their receipts and wait until the end of the tax year to claim their rebate.

For every dollar donated you receive a third back as a tax credit in the same pay period.

Tax credits for payroll donations are calculated at 33.33 cents for each dollar donated, which is deducted from your PAYE. This means that if you give \$10 you will only be contributing \$6.67 from your net pay, with the remainder coming from the tax you would otherwise pay.
